# **DOMESTIC VIOLENCE**

## The Law

The law protects you if you are being abused or threatened by an intimate partner, spouse, former spouse, person with whom you have a child in common or another family or household member who is or WAS living in the same household as you as a family. You need not be married to the abuser or related to be protected under the law.

# **Your Rights**

You have the right to file a criminal complaint and go to court and file a petition requesting an injunction for protection from domestic violence which may include, but not limited to, provisions which:

- Order the abuser not to commit any further acts of abuse
- Direct the abuser to leave your household
- Prevent the abuser from entering your residence, school, business or place of employment
- Award you custody of minor children

# **Redflags For High Lethality Cases**

- Ownership "If I can't have you, nobody will"
- Obsession with and/or domination over you
- Repeated Intervention Past domestic violence history
- Escalation of risk taking Acting without regard for consequences
- Threats of Homicide/Suicide
- Access to and threatened use of handguns
- Drugs and Alcohol abuse
- Family history of domestic violence

# DOMESTIC VIOLENCE UNIT

The Domestic Violence Unit was formed in 1998 and is part of the Palm Beach County Sheriff's Office, Special Investigations Division. The Unit is supervised by a Sergeant and consists of Detectives, Victim Advocates and Volunteer Advisors. The Domestic Violence Unit monitors the D.A.R.T. (Domestic Abuse Response Team) program and the Domestic Violence website which allows immediate access to crucial case information to include photographs at the various stages of the Criminal Justice process. Members of the Domestic Violence Unit are involved in many community organizations to include the Domestic Violence Council, Human Trafficking Coalition, the Victim's Rights Coalition and the Palm Beach County Fatality Review Team.



# **D.A.R.T. PROGRAM**

Domestic Abuse Response Team members are specially trained Deputy Sheriff's who have received advanced training in the identification and investigation of Domestic Violence incidents. D.A.R.T. members are issued additional equipment to assist in the collection of crucial evidence to include tape recorders and digital cameras.



# DOMESTIC VIOLENCE DETECTIVES

**Detectives assigned to the Domestic Violence Unit are** highly motivated and skilled investigators who perform a number of duties on a daily basis, including, but not *limited to, the following:* 

- Conduct departmental training to include, D.A.R.T training, Florida Department of Law Enforcement mandated training and new employee orientation.
- Review all Domestic Violence offense reports to ensure that all investigative and statutory requirements are being met.
- Work in conjunction with Victim Advocates and Volunteer Advisors to ensure that victims of Domestic Violence are receiving the best services possible.
- Provide assistance to Road Patrol deputies while . investigating Domestic Violence investigations by offering guidance.

# DOMESTIC VIOLENCE **VICTIM ADVOCATES**

The primary goal of the PBSO Victim Advocates is to reduce secondary injuries or trauma associated with the aftermath of crime by providing counseling, information and assistance, as well as referrals to appropriate agencies for additional services. **Responsibilities include but are not limited to:** 

- Safety Planning.
- Providing guidance and support throughout the Criminal Justice Process.
- Court Accompaniment and assistance with filing an Injunction for Protection.
- Liaison between law enforcement and various agencies involved in the criminal case.
- Provide education and awareness about the dynamics of domestic violence and its impact on victims/families.
