# AGREED ORDER ON DEFENDANT, MATTHEW T. MCGEEVER'S CLAIM OF EXEMPTION IN PERSONAL PROPERTY [DE #161] AND INTERESTED PARTY, STEPHANIE NGO-HATCHIE'S MOTION FOR RELEASE OF PERSONAL PROPERTY [DE #160]

#### AND CANCELLING SPECIAL SET HEARING

THIS CAUSE having come before the Court on Defendant, MATTHEW T. MCGEEVER's Claim of Exemption in Personal Property [DE #161] and Interested Party, Stephanie Ngo-Hatchie's Motion for Release of Personal Property [DE #160], and the Court being advised that the parties are in agreement, it is hereby:

#### **ORDERED AND ADJUDGED** that:

- 1. The Plaintiffs dispute the merits of claims asserted in MATTHEW T. MCGEEVER'S ("MCGEEVER") Claim of Exemption in Personal Property [DE #161] and Interested Party, Stephanie Ngo-Hatchie's ("Ngo-Hatchie") Motion for Release of Personal Property [DE #160].
- 2. However, in order to resolve the hearing currently set for Friday, June 6, 2025, at 1:00 P.M., the parties have agreed as follows.
- 3. The Sheriff is authorized to release to MCGEEVER and MCGEEVER shall be entitled to retrieve **only** the items set forth in **EXHIBIT A**, hereto. MCGEEVER's personal property exemption pursuant to Article X, Section 4 of the Florida Constitution and Fla. Stat. 222.25(4), in the amount of \$5,000, shall apply to these items, only, and MCGEEVER shall not be permitted to apply the exemption to any other personal property acquired in the future.
- 4. The Sheriff is authorized to release to Ngo-Hatchie and Ngo-Hatchie shall be entitled to retrieve **only** the items set forth in **EXHIBIT B**, hereto.

- 5. MCGEEVER and Ngo-Hatchie shall make arrangements to retrieve the aforementioned items within 7 days from the date of this Order and shall be solely responsible for all costs, including, but not limited to, any costs charged by the Sheriff, associated with retrieving these items from the Sheriff or otherwise effectuating the Court's ruling pursuant to this Order.
- 6. MCGEEVER and Ngo-Hatchie relinquish any and all claims regarding the remaining items seized by the Sheriff which shall be sold by the Sheriff at the Sheriff's Sale on Monday, June 17, 2025. The Sheriff is authorized to publish this Order to any parties necessary in connection with the conduct of the sale. The sale shall not be postponed.
- 7. The Plaintiffs are permitted to conduct future levies on personal property of MCGEEVER but agree not to seek retrieval of the items set forth in **EXHIBIT A** or **EXHIBIT B**, in future levies. In the event that any of the items set forth in **EXHIBIT A** or **EXHIBIT B** are taken by the Sheriff in future levies then the Plaintiffs agree to release those items back to MCGEEVER and/or Ngo-Hatchie.
- 8. The parties will bear their own attorney's fees and costs incurred in connection with the subject levy.
- 9. The special set hearing schedule for Friday, June 6, 2025, at 1:00 P.M., on MATTHEW T. MCGEEVER's ("MCGEEVER") Claim of Exemption in Personal Property [DE #161] and Interested Party, Stephanie Ngo-Hatchie's ("Ngo-Hatchie") Motion for Release of Personal Property [DE #160] is **HEREBY CANCELLED.**
